## BOARD OF DIRECTORS

The local property tax system follows the principle of checks and balances. The appraisal district board of directors hires the chief appraiser and sets the budget. The directors have no authority to set values or appraisal methods. The chief appraiser carries out the appraisal district's legal duties, hires the staff, makes the appraisals and operates the appraisal office.

The Board of Directors of the Maverick County Appraisal District consist of five voting members and one nonvoting member. The directors are appointed by the eligible taxing units inMaverick County according to Section 6.03 of the Texas Tax Code.

The non voting member is the current Tax Assessor-Collector for Maverick County.
